Note – No outdoor storage of non-motorized equipment associated with a non-residential use -i.e. pallets, trailers, soil, unplanted landscaping material, will be allowed in a residential zone. Note: A Special Use Permit shall be required for any public park to be located in the LC-NC/SE and LCNC/GI zoning classification.
